**Cancellation Policy:** Because we base our irrevocable space rental commitment on your participation commitment, your deposit of 50% of the total participation fee is non-refundable. The remainder of the participation fee must be paid no less than 140 days prior to the Opening Day of the show or your space reservation will be cancelled. If a cancellation is made after payment of the total participation fee, the following guidelines will apply: (a) if written notification of exhibitor's intention to cancel is received by Concord Expo Group more than 140 days before the Opening Day of the show, then 50% of the total participation fee less a \$500 handling fee will be refunded to exhibitor; (b) If written notification of an exhibitor's intention to cancel is received by Concord Expo Group within 140 days of the Opening Day of the show, then the total participation fee will be forfeited by exhibitor. The participation fee is based on the current exchange rate and is subject to adjustments, German regulations and VAT (Value Added Tax).
